

**OFFICIAL RULES OF THE MCKINNEY EDUCATION FOUNDATION  
"EDUCATION DRIVES THE FUTURE" CAR RAFFLE**

By entering the McKinney Education Foundation Raffle (the "Raffle"), you consent to be bound by these Official Rules. Accordingly, you should read these rules carefully before entering the Raffle.

1. ORGANIZATION CONDUCTING RAFFLE: The Raffle is being conducted by the McKinney Education Foundation ("MEF"), which is solely responsible for the Raffle, the administration of these Official Rules, and the awarding of the prize. Net proceeds from the Raffle will be distributed to MEF.

2. ELIGIBILITY: To be eligible to enter the Raffle, you must comply with these Official Rules, and either be a resident of Texas or purchase your ticket in person in Texas.

3. HOW TO ENTER: You have not entered the Raffle until your entry submission, with full payment, has been accepted by MEF. Acceptance of your entry submission will be communicated to you by delivery of a ticket stub or by a written confirmation letter from MEF. If a submission is accepted, then it will be deemed to have been accepted on the date and time on which the submission was received by MEF, regardless of the date that MEF notifies you of the acceptance of your submission. You may enter as often as you want, but all entry requirements must be met for each entry. Tickets will be sold up until the final drawing on the night of the event, May 28, 2010, or until 999 entries are accepted, whichever comes first. There are 4 ways to submit your entry:

(a) Submission by Mail: Legibly complete the official entry form and send it by first class mail, postage paid, along with required credit card information, to: McKinney Education Foundation, 510 Heard Street, McKinney, Texas 75069. Entrants are discouraged from sending cash, checks, money orders or other forms of negotiable instruments through the mail.

(b) Submission by Internet: Access the official MEF website at [www.MmEeFf.com](http://www.MmEeFf.com) ("Raffle Website"), navigate to the Car Raffle entry page, and complete the Raffle entry form by providing all requested information, and then clicking "submit." Entry via the Internet will not be available for those who reside outside of a limited geographical region within Texas.

(c) Submission in Person: Purchase your ticket in person from an authorized employee or volunteer of MEF by completing the official entry form, and handing the completed official entry form, along with a check, money order, or required credit card information, to one of MEF representatives present.

(d) Submission by phone: Purchase your ticket over the telephone from an authorized representative of MEF by providing entry and payment information to the representative. (Receipt by a volunteer of entry information and payment DOES NOT constitute acceptance of your entry submission.)

4. ODDS OF WINNING: The odds of winning the Grand Prize will not exceed 1 out of 999, but may be more favorable depending on the number of entries.

5. PROCEDURES FOR LIMITING ENTRIES: The number of entries into the Raffle shall be limited to 999. If 999 submissions are accepted prior to the closing date of May 28, 2010 no further submissions will be accepted.

6. METHOD FOR AWARDING GRAND PRIZE: MEF will conduct a drawing for the Grand Prize on May 28, 2010. You need not be present at the Grand Prize drawing to win. However, the Grand Prize will be available at the dealership in Collin County, Texas for winning entrant.

7. PRIZES: The prize cannot be substituted by the winner, other than taking the cash value of the car at the time of the drawing. MEF reserves the right to substitute a prize of equal or greater value, at its discretion. The Grand Prize will be a 2010 Ford Fusion Hybrid (vehicle awarded to winner will have actual demo mileage).

#### 8. GENERAL CONDITIONS

(a) The winner must execute and provide to MEF: (1) a Liability Release, releasing the Sponsors (as defined below) from any liability arising out of the Raffle; and (2) a Publicity Release, allowing MEF to use the winner's name, likeness, voice and biographical information for publicity purposes. The winner also will be required to provide any other information needed by MEF to comply with applicable laws and regulations, including those relating to the payment of income taxes. By accepting a prize, the winner grants MEF permission for the use of his/her name, likeness and biographical information for advertising and promotional purposes without additional compensation, except where prohibited by law.

(b) MEF reserves the right, exercisable upon its sole discretion, to disqualify any individual found to have (1) violated these Official Rules; (2) interfered with the entry process or the operation of the Raffle; (3) altered or attempted to alter the random outcome of the Raffle; (4) violated any law or regulation by participating in the Raffle; or (5) fraudulently completed the entry form or provided other false information to MEF.

(c) IN NO EVENT WILL MEF OR ITS BOARD MEMBERS, AGENTS OR EMPLOYEES (COLLECTIVELY, "SPONSORS"), BE LIABLE FOR ANY DAMAGES OR LOSSES OF ANY KIND, INCLUDING DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL, STATUTORY OR PUNITIVE DAMAGES. WITHOUT LIMITING THE FOREGOING, WITH RESPECT TO THE RAFFLE AND TO THE PRIZES, THE SPONSORS MAKE NO WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

(d) All taxes, fees, assessments, title and registration fees, insurance, and like charges, associated with the receipt or use of the prize are the sole responsibility of the winner. BECAUSE OF THE VALUE OF THE PRIZE, THE WINNER WILL BE REQUIRED TO MAKE A PAYMENT OF TAXES IN THE AMOUNT OF 25% OF THE FAIR MARKET VALUE OF THE GRAND PRIZE AT THE TIME OF ACCEPTING THE PRIZE. THE TAXES MUST BE PAID AND THE GRAND PRIZE MUST BE PICKED UP AT THE DEALERSHIP (BOB TOMES FORD LINCOLN MERCURY, 950 S. CENTRAL EXPWY., MCKINNEY, TEXAS 75070), NO LATER THAN JUNE 28, 2010.

(e) The value of the prize is based upon good faith estimates by MEF as of the date the Raffle was commenced. The Sponsors assume no responsibility for changes in market conditions that may impact the value of the prize. There is no guaranty that a winner will be able to sell the prize for the estimated value or that the IRS, or its counterpart in any state's jurisdiction, will accept the value of the prize for purposes of determining any tax that may be due by the winner.

(f) Entrants hereby fully release the Sponsors from any and all liability caused by or resulting from the use or possession of any prize awarded or caused by or resulting from participation in the Raffle or any related promotion.

(g) MEF assumes no responsibility for lost, late, misdirected or undelivered entry submissions, or any error, delay, or interference with entry via the Raffle Website.

9. DISPUTE RESOLUTION: Venue of any action brought concerning the Raffle shall be in McKinney, Texas, and shall not be subject to transfer to another venue or locale for any reason. By entering the Raffle, you agree that you will not commence or participate in any class action litigation, or join with any other person in a legal proceeding, concerning the Raffle. The Raffle, these Official Rules, the entire relationship between you and MEF, and any legal proceeding arising there from (whether based on contract, tort, law or equity), shall be governed by, construed in accordance with, and enforced pursuant to, the laws of the State of Texas, without regard to its conflict of laws principles.

11. AMENDMENT OF RULES: If, for any reason, the administration, security, fairness, or integrity of the Raffle has been compromised, MEF reserves the right, exercisable at its sole discretion, to cancel, terminate, modify or suspend the Raffle. The Official Rules may be amended by MEF in its sole discretion. Amendments will be posted on the Raffle Website. Unless otherwise specified, any amendments will become effective at 12:00:01 a.m. CT on the day after they are posted on the Raffle Website.
